Information for authors

All abstracts and subsequently full papers should be submitted electronically. Each paper will be reviewed and all accepted papers will be published in the Book of proceedings. International review and oral presentation of the papers are prerequisites for the publication in the Thematic Proceedings of International Significance. The official Conference language is English.

An abstract should include:

- the name of the section it belongs to,
- the title of the work, the full name and the address (including e-mail) of the author, the affiliation,
- between 100-200 words,
- Keywords.

Author/co-author is allowed to submit maximal two papers, but only one paper as the first author. Papers should have no more than 14 pages prepared according to the Template.
